# Project background and description

Collaboration with countries that have applied to join the EU has been one of ECDC's strategic priorities since the early years of its establishment, and is endorsed in the ECDC Strategy 2021–2027. It is the sixth ECDC project with external financial assistance by DG NEAR under the Instrument of Pre-Accession Assistance (IPA) aimed to prepare the national authorities of the Western Balkans and Türkiye for their future participation in ECDC activities. The beneficiaries of this ECDC-IPA6 project benefit from a European perspective that was granted to them by the European Parliament and the Council, i.e. Albania, Bosnia and Herzegovina, Kosovo¹, Montenegro, Serbia, North Macedonia, and Türkiye (IPA beneficiaries).

### **Project scope**

The project's scope is to contribute to increased health security in the EU through international collaboration and alignment regarding infectious disease policies and practice. Within the action area on strengthened cooperation and coordination between ECDC and partners in the EU neighbourhood, ECDC supports Western Balkans countries and Türkiye to strengthen their infectious disease prevention and control systems and public health workforce.

The aim of the project is to support national counterparts in IPA beneficiaries in their preparation for full participation in ECDC's technical activities and to enhance IPA beneficiaries' capacities to advance One Health responses against antimicrobial resistance (AMR) and enhanced severe acute respiratory infection (SARI) surveillance.

### Work plan 2023

Work Stream 1. 'Preparatory measures for participation of IPA beneficiaries' authorities in ECDC activities and systems' aims to further support national counterparts in the IPA beneficiaries in their preparation for full participation in ECDC's work'

Following discussions in the Annual Meeting of National ECDC Correspondents in November 2022, countries will continue reporting data to ECDC on agreed diseases and gradually expand the scope to covering emerging and vector-borne diseases and sharing technical information on potential crossborder threats via EpiPulse.

Data submitted by Western Balkans countries and Türkive on mutually agreed diseases will be regularly reviewed and discussed with national surveillance contact points in order to increase the level of EU-level data quality in terms of the comparability, timeliness, and reliability of communicable diseases surveillance data. In addition, ECDC will propose to Western Balkans countries and Türkiye that the agency conduct technical country visits to discuss the surveillance of communicable diseases; country visit reports will be delivered that include analysis of strengths and challenges as well as recommendations for further improvement. The dates of such country visits are to be agreed with key counterparts in each beneficiary country.

## Work Stream 2. Advancement of One Health approaches against AMR
