Establishment of the EU Health Task Force



Background: Shortcomings in EU mechanisms for managing threats, lack of readily available human resources for timely deployment → ECDC amended mandate to establish and coordinate EUHTF in collaboration EC, EU/EEA MS

Vision: EUHTF as an **EU deployable public health work force** providing effective **operational response** and **crisis preparedness support** to EU/EEA MS and contributing to wider global health security;

- Country or crisis focused
- Flexible body, mobilised in different situations and under different mechanisms
- Work closely with the European Commission, close collaboration with international partners such as WHO GOARN
- Remote support as well as rapid in-country field deployment

Scope: Timely emergency response during outbreaks and crises
Communicable disease and diseases of unknown origin
Strengthening countries emergency preparedness

Enhanced Emergency Capacity

Large mobilisations of the EUHTF in the event of the declaration of a public health emergency, under the EC and ECDC coordination

As per routine ECDC governance mechanisms, the EUHTF reports annually to:

- ECDC **Advisory Forum** on EUHTF scientific work
- ECDC **Management Board** on EUHTF activities (workplan and budget)

Activities and achievements: EUHTF assignments to date



Since 2023, the EUHTF has received **26 requests for support**

- 23 -> Accepted
 - Status - ongoing (4), completed (17) and discontinued (2)
- 3 -> decided as outside of scope of EUHTF work



Experts engaged

- 15 experts deployed internationally
- Over 30 experts engaged in-person and remotely



Location

- 15 assignments in EU/EEA countries
- 6 assignments in third countries

- Emergency/Outbreak response - 7
- Mass gathering - 2
- Rapid risk assessment - 1
- After-action review - 4
- Capacity building - 4
- Simulation exercise - 2

DRC: Support to **mpox response**, through GOARN, DG ECHO and DG INTPA

- Engaged 10 experts, providing continuous support from July-Dec 2024

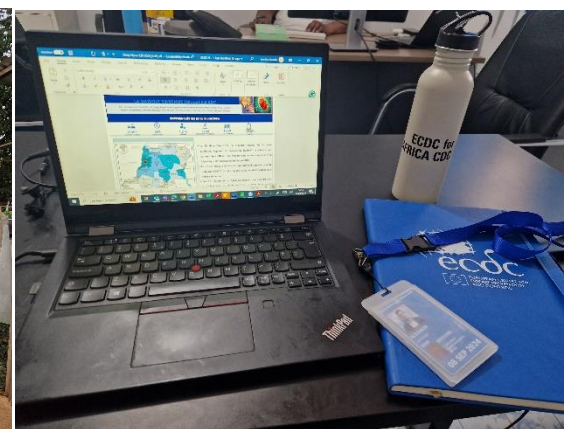

EUHTF Assignments outside of the EU/EEA, in collaboration with partners

Ukraine: Rapid Risk Assessment related to a flooding event

Israel and occupied Palestinian Territories: Response to infectious disease events associated with the escalation of violence, through GOARN and DG ECHO (in support of UNRWA HQ in Jordan)

Zambia: Response to cholera, through GOARN and DG INTPA to WHO

Rwanda: Response to Marburg virus disease, with DG ECHO through UCPM

Global Outbreak Alert and Response Network (GOARN)


- Member of the EUHTF Advisory Group
- ECDC is member of the GOARN Steering Committee
- Support GOARN initiatives (e.g., MEAL, RRML, OR, training, Opps. call)
- Upon GOARN request for assistance, the EUHTF can rapidly identify EUHTF experts to assist WHO or other UN organisations – targeted approach
- EUHTF can arrange deployments under the leadership of WHO/GOARN or of the organisation requesting assistance
- Though self-funding or EU partners (e.g. DG ECHO, DG INTPA) EUHTF funds ECDC deployments with GOARN

DG for European Civil Protection and Humanitarian Aid (DG ECHO)

- Member of the EUHTF Advisory Group
- Service level agreement between ECDC and DG ECHO, to extend to external experts
- Ensuring logistical support and safety & security to EUHTF deployed experts
- Deployment mechanisms include:
 - Union Civil Protection Mechanism (UCPM)
 - European Humanitarian Response Capacity (EHRC)
 - RescEU (in progress)
- Providing public health expertise to UCPM teams, European External Action Service, ECHO field offices or to other partner agencies

Criteria for request for support to the EUHTF

Who?

Geographical scope? (in order of priority) EU/EEA countries, EU candidate countries, potential candidate countries, European Neighbourhood Policy countries and other partner countries.

Focus? One country or one crisis, emergency preparedness or response, infectious diseases or outbreaks of unknown origin

Technical support for an **ad hoc preparedness** activity that is country/setting specific and addresses a specific technical gap

OR

Technical support for an **emergency, outbreak response**, focused on investigation, prevention and control activities

Time-limited support
OR
Requiring part-time support over medium-term

Clear public health impact for the EU/EEA or globally

Process to mobilise EUHTF support and expertise

How to request support

Evaluate Request

- Scoping call ECDC/requestor



- Clear justification
- Alternative solution if available



- Build request: clarify scope, timing, location, output
- Build ToR

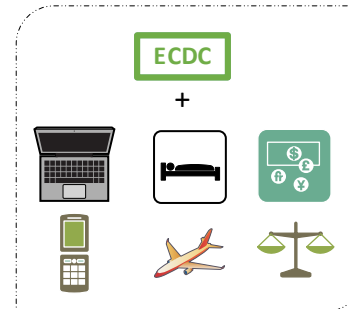
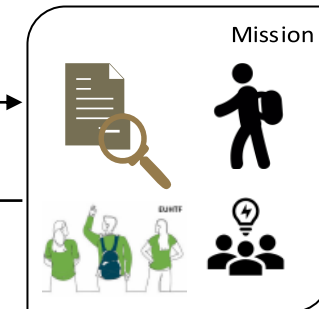
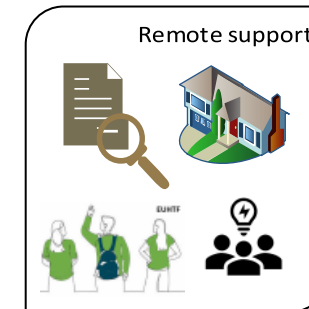

Expert selection process

- ECDC Coordination Team selects experts based on competencies and ToRs
- MS requesting support is informed and endorsement is requested

Assignment



Closure of support

- Report/mission outcome
- Debriefing
- Feedback from requestor
- Feedback from expert
- Awareness and communication activities

COMPLETED

EUHTF expert pool – selection for an assignment

Based on the **specific TORs** for the assignment

- Availability at required time
- Technical expertise/competences
- Language
- Other requirements e.g. HEAT training.

Selection takes additional factors into account, to establish a balanced response team e.g. level of seniority

EUHTF expert pools – collaboration and benefits



What collaboration with experts?

- Field or remote work
- Deployments always with an ECDC staff
- Deployment **logistical support** (i.e., travel, accommodation, insurance, equipment, per diem)
- **Continuous contact** and follow up; regular calls, reports and feedback
- Supervision and **technical support**
- Debrief to learn from what went well and challenges

What benefits does participation offer?

- **Practical learning** opportunity for supporting expert
- Community of practice: **networking** with public health professions in similar fields
- Opportunity to participate in **trainings**


