## **System Administrator**

Applications are invited for the above Contract Agent post at the European Centre for Disease Prevention and Control (ECDC).

## **Job description**

ECDC plans to recruit one person for a project post. ECDC also aims to establish a reserve list, which may be used for any future vacancies in the area.

The jobholder will report to the Back Office Group Leader. The jobholder will be responsible in particular for the following areas of work:

- Administer, maintain and optimise the servers, container and storage infrastructure, both on premise and in the cloud;
- Administer, maintain and optimise centralised back office applications with focus on the server environments, the corresponding databases, the Active Directories including ADFS and Azure AD;
- Contribute to application development and deployment as part of a DevOps team;
- Support, administer and maintain the container management environment using orchestration and CI/CD pipelines;
- Assist in defining the IT infrastructure architecture and standards in accordance with the application requirements, the baseline architecture and the business continuity plans;
- Document the IT infrastructure and services and maintain the documentation:
- Monitor and analyse technical logs in order to ensure security and service continuation;
- Ensure second- and third-line support for the ECDC and external users for the back office services;
- Write scripts to automate various tasks as needed for administrative or application integration purposes;
- Be available for periods of stand-by duties at weekends and nights with remote administration facilities on a rotation basis with the other group members;
- Any other tasks related to his/her area of work as requested.

### Qualifications and experiences required

### A. Formal requirements

In order to be an eligible candidate you need to fulfil a set of formal requirements. These requirements are:

- A level of education which corresponds to completed university studies of at least three years attested by a diploma <sup>1</sup>;
- Thorough knowledge of one of the official EU languages and a satisfactory knowledge of another official EU language to the extent necessary for the performance of his/her duties<sup>2</sup>;
- Nationality of one of the EU Member States or of Norway, Iceland or Liechtenstein;
- To be entitled to his or her full rights as a citizen<sup>3</sup>;
- To have fulfilled any obligations imposed by the applicable laws on military service;
- Meet the character requirements for the duties involved; and
- Be physically fit to perform the duties linked to the post.

#### **B.** Selection criteria

To qualify for this post we have identified **essential criteria** with regard to professional experience/knowledge and personal characteristics/interpersonal skills.

#### Professional experience/knowledge:

- At least 3 years, following the award of the diploma, of professional experience acquired in positions relevant to the job description;
- Experience working as System Administrator in a DevOps based environment;
- Experience working with system administration as second- and third-line support, troubleshooting and diagnostic procedures based on ITIL practices;
- Extensive knowledge and experience in the design, operation and maintenance within the following domain areas:
  - MS Windows Server 2016/2019/2022 and Active Directory / Active Directory Federation Services / Azure AD
  - Azure administration
  - High Availability and Disaster Recovery
  - Automation of tasks / Infrastructure as code
  - Container technologies
- Knowledge and experience in the design, operation and maintenance with product experience in at least 11 out of the following 17 areas:
  - MS Hyper-V
  - Azure Devops

Depending on the number of applications received, the selection committee may apply stricter requirements within the aforementioned selection criteria.

ECDC is an equal opportunities employer and encourages applications from all candidates who fulfil the eligibility and selection criteria without any distinction on grounds of age, race, political, philosophical or religious conviction, gender or sexual orientation and regardless of disabilities.

# **Appointment and conditions of employment**

The jobholder will be appointed on the basis of a shortlist proposed by the Selection Committee to the Director. This vacancy notice is the basis for the establishment of the Selection Committee's proposal. Candidates will be requested to undergo written tests. Candidates should note that the proposal may be made public and that inclusion in the shortlist does not guarantee recruitment. The shortlist of candidates will be established following an open selection process.

The successful candidate will be recruited as a contract agent, pursuant to article 3a) of the Conditions of Employment of Other Servants of the European Union, for a limited period of 5 years with a contract that may be renewed depending on the project funding. for a period of five years. The contract may be renewed. The appointment will be in **Function Group IV**.

Applicants should note the requirement under the EU staff regulations for all new staff to successfully complete a probationary period of nine months.
