Applications are invited for the above Contract Agent post at the European Centre for Disease Prevention and Control (ECDC).

Job description

ECDC plans to recruit one person for the above-mentioned vacancy. ECDC also aims to establish a reserve list, which may be used for any future vacancies in the area.

The jobholder will report to the Group Leader of the Microbiology and Molecular Surveillance Group while working closely with the other teams from the Surveillance Section, Disease Programmes and Digital Transformation Services. He/she will be placed in the Surveillance Section in the Public Health Functions Unit.

The jobholder will be responsible in particular for the following areas of work:

- Managing and improving ECDC databases for Whole Genome Sequencing (WGS) and molecular typing data;
- Using bioinformatics tools for the analysis and visualisation of WGS data for all pathogens listed as priority for ECDC in terms of genomic typing;
- Maintaining and extending scripts related to the collection and validation of molecular surveillance data, and related visualisation / data exploration tools;
- Generating and disseminating pre-defined outputs from WGS and other molecular typing data;
- Contributing to the analysis and interpretation of molecular typing data in the context of detecting, assessing, monitoring and communicating public health threats for the EU;
- Presenting information from WGS data analysis to ECDC internal experts and EU/EEA Member State stakeholders;
- Contributing to other activities of ECDC as required, within his/her field of competence;
- May be asked to contribute to the 24/7 duty system of ECDC.

Qualifications and experiences required

A. Formal requirements

In order to be an eligible candidate you need to fulfil a set of formal requirements. These requirements are:

- A level of education which corresponds to completed university studies of at least three years attested by a diploma ¹;
- Thorough knowledge of one of the official EU languages and a satisfactory knowledge of another official EU language to the extent necessary for the performance of his/her duties²;
- Nationality of one of the EU Member States or of Norway, Iceland or Liechtenstein;
- To be entitled to his or her full rights as a citizen³;
- To have fulfilled any obligations imposed by the applicable laws on military service;
- Meet the character requirements for the duties involved; and
- Be physically fit to perform the duties linked to the post.

B. Selection criteria

To qualify for this post we have identified **essential criteria** with regard to professional experience/knowledge and personal characteristics/interpersonal skills.

Professional experience/knowledge:

- University degree within the field of bioinformatics, microbiology, epidemiology, biosciences or another related area:
- At least 3 years, following the award of the diploma, of professional experience acquired in positions relevant to the job description;
- Experience in use of WGS analyses for disease prevention and control at the international, national and/or local level, preferably also in the context of outbreak detection and investigation;
- Knowledge and experience of relevant technologies for bioinformatic purposes (e.g. Python, SQL, CLC bio, and open-source bioinformatics tools);
- Excellent level of English, both written and spoken.

Personal characteristics/interpersonal skills:

- Excellent oral and written communication skills;
- Ability to work collaboratively and build strong multi-disciplinary working relationships;
- Results oriented with the ability to work under pressure and prioritise tasks;
- Quality-driven and service-minded.

¹ Only diplomas and certificates that have been awarded in EU member states or that are the subject of equivalence certificates issued by authorities in the said Member states shall be taken into consideration.

² Candidates with a non-official EU language or English as their mother tongue must provide proof of their level of a second language with a certificate (B1 or more).

³ Prior to the appointment, the successful candidate will be asked to provide a certificate from the police file to the effect of non-existing criminal record.

Depending on the number of applications received, the selection committee may apply stricter requirements within the aforementioned selection criteria.

Equal Opportunities

ECDC is an equal opportunities employer and encourages applications from all candidates who fulfil the eligibility and selection criteria without any distinction on grounds of age, race, political, philosophical or religious conviction, gender or sexual orientation and regardless of disabilities.

Appointment and conditions of employment

The jobholder will be appointed on the basis of a shortlist proposed by the Selection Committee to the Director. This vacancy notice is the basis for the establishment of the Selection Committee's proposal. Candidates will be requested to undergo written tests. Candidates should note that the proposal may be made public and that inclusion in the shortlist does not guarantee recruitment. The shortlist of candidates will be established following an open selection process.

The successful candidate will be recruited as a contract agent, pursuant to article 3a) of the Conditions of Employment of Other Servants of the European Union, for a period of five years. The contract may be renewed. The appointment will be in **Function Group IV**.

Applicants should note the requirement under the EU staff regulations for all new staff to successfully complete a probationary period of nine months.

ECDC will not accept any applications after the deadline. Once you have submitted your application, you will receive an automatic e-mail message confirming receipt of your application. Please ensure that the email address you provide for your applicant account is correct and that you check your email regularly.
