I am a dedicated and committed public health specialist. Over the years I have developed skills in the wide aspect of the public health specialty.

During this time, I have tackled for many of the aspects of public health and am particularly interested in the specialty of epidemiology. I have been the lead for the development and implementation of major policies for Malta in the field of Public Health. I have found that my work contributes to public health promotion and protection and this has provided me with great job satisfaction.

Following the attainment of the medical degree, I pursed my studies with masters in public health and consequently followed the European Programme in Epidemiological Training (EPIET) in France.

I have specialized in fitness and nutrition and have developed a programme for weight management as part fulfilment of the diploma.

I have attained my PhD Degree in communicable disease epidemiology in 2006. I am a fellow of the UK Royal Society for Public Health (FRSPH) and a fellow of the UK Faculty of Public Health (FFPH. I am registered as a specialist in Public Health Medicine with the Specialist Accreditation Committee in accordance with the Health Care Professions Act 2003 since 2003.

Currently I occupy position of Superintendent of Public Health/ Director General Health Regulation, I had previously occupied position of Director Health Promotion and Disease Prevention Directorate for 9 years.

I am currently leading the public health response to the COVID-19 pandemic in Malta with a dedicated team of professionals forming the COVID-19 PH Response team.

I was the technical lead during the term of the Maltese Presidency of the Council of the European Union Jan 2017-June 2017 for childhood obesity and HIV. The main outcomes were the development of the Procurement Guide for food for health in schools, Council conclusions on halting childhood obesity and Malta technical HIV Declaration.

I have an appointment as an associate professor at the University of Malta and deliver lectures in the field of public health with special interest in Epidemiology and Communicable Diseases, Policy development, Health Promotion and Disease Prevention. I currently assist in the coordination of the Public Health masters course organized by the Public Health Department.

I have served as President of the Malta Association of Public Health Medicine for the term December 2009-2011 and December 2011-2013 after having served as vice-resident for two years and secretary for four years.

I sat on the Public health training committee, which is responsible for setting up of training in the public health specialty for over 10 years. I am also a lead location trainer for public health trainees who are attached with the department.

I am also a Foundation Training Programme Director at the Foundation School responsible for the management and quality control of the foundation programme.

I have great interest in research work and further education especially in the field of epidemiology and carry out various research projects. I form part of the Editorial Board of the "International

I have been in head ship position since 2007, as director of Health Promotion and Disease Prevention Directorate for 9 years for the period 2007-2016 and in position of Director General/Superintendent of Public Health from 2016 till date. I have been appointed as consultant in Public Health Medicine in November 2009.

The Superintendent of Public Health gives direction to the directorates falling within the Public Health Regulation Department and ensure that the regulatory and public health protection functions emanating from law are properly and effectively discharged. This covers areas of health promotion and disease prevention, environmental health, health care standards and licencing and health care professionals regulation. The Superintendent of Public Health assists and advises the Ministry on the formulation of regulations and standards and ensure that regulations and standards which are promulgated by Government are implemented by both state and private service providers. It will be the responsibility of the Superintendent of Public Health to monitor standards, license and inspect health care services and care and where necessary, enforce regulations.

Technical Lead for Priority area on childhood obesity: Maltese Presidency of the Council of the European Union- During the term of presidency in 2017, I was nominated technical lead on the area of childhood obesity whereby I led a team to develop this area. ACADEMIC PROFESSION

I have been appointed as resident lecturer (T2) with the University of Malta, Public Health Department since October 2007 and consequently promoted to senior lecturer in June 2009, I have been promoted to resident academic senior lecturer TR4 since January 2013 and An associate professor since March 2016.

I am responsible for the delivery and assessment of study units in Epidemiology, Communicable Diseases and Disease Surveillance, Health Promotion and Non-Communicable Disease Prevention. I deliver many lectures within the faculty of Medicine and Surgery and within other faculties including the Faculty of Health Sciences, Faculty of Education and Faculty of Media and Knowledge Sciences at an undergraduate and post graduate level. I have supervised many students for their dissertation, including those reading MSc Public Health, BSc Environmental health, B. Ed.B. Comm and have acted as an advisor for a number of students. I am also currently a co-supervisor of a PhD student.

I currently assist in the coordination of the Masters course of Public health with the University of Malta. I also formed part of the training committee (representing the Superintendent of Public Health) for over 10 years which is responsible for setting up training in the public health specialty. I am the principal lead trainer and responsible for the training of doctors attached with the Public health regulation department.

I participated in PHTECE which is responsible for harmonizing public health training in Europe and have attended workshops organized by this team.

I have led many research projects in various fields, published a number of papers in peer reviewed journals, abstracts and posters in conferences and am a reviewer for a number of journals and have reviewed over 40 papers.

Through my role with the Ministry for Health, I have contributed to society, culture and the economy at large in professional service to the country and the international community. This has been further enhanced through my lead in the health priority theme on childhood obesity during the term of the Maltese presidency of the council of the European Union whereby added value was created at EU level and having led to the development of council conclusions on this area.

FOUNDATION TRAINING PROGRAMME DIRECTOR (FTPD)

I have been appointed FTPD since 2015 with responsibilities of ensuring that all foundation doctors in the programme have access to suitable training and are progressing well, working with local educators, and clinical supervisors to make sure that specific placements in the training programme are delivering the appropriate quality of training, and working with the Foundation School Directors



and faculty to ensure foundation training benefits from a coordinated approach. I am also on the audit and quality improvement team of the Foundation School.

The Directorate is responsible for preventing illness and promoting health in order to improve the health and well-being of the Maltese population. My role as Director was to provide leadership for health promotion to reduce/delay the onset of illness. In this function, I am responsible for promoting healthy lifestyles amongst the population and working in partnership with other Ministries and external stakeholders to tackle the determinants of illness, particularly to reduce the disease burden caused by non-communicable diseases. As a Director I am responsible to ensure that services within the directorate are operating in line with the Ministry's policy, strategy, regulations and standards.

July 1998-September 2007

HEAD OF DISEASE SURVEILLANCE UNIT (July 1998 to September 2007)

I started working with the Department of Public Health in July 1993 as a medical officer. I obtained a post as medical officer in public health on the 3rd June 1996. I was promoted to senior medical officer on the 25th June 1998 when I was appointed Head of Disease Surveillance Unit within the Department of Public Health where I was responsible for a team of 20 people. Consequently, I was then appointed as Principal Medical officer on the 13th June 2001.

The work involved mainly the surveillance of communicable diseases at national level in Malta and the international cooperation with other countries. The work included:

- Investigation and follow up of reported Notifiable Diseases
- Setting up an outbreak control team in case of outbreaks
- Communication with various disease specific networks and provision of information to the ECDC/WHO.
- Responsibility for the early warning and response system of the ECDC (24hr/7 day on call for urgent alerts)
- Issuing recommendations for improving prevention and control of Communicable Diseases
- Co-ordination of Health Promotion in conjunction with other sectors
- Initiation of surveys and statistical interpretation of data
- Assisting the Director of Public Health in the investigation of reports of breaches of the relevant national Health Laws and Regulations.
- Screening of laboratory results
- Focal point for a number of disease specific networks under the ECDC



including early warning and response system (EWRS), RAS-BICHAT, Enter-Net and Epi-South.

I was also responsible for taking up duties of the Director of Public Health when the latter is abroad or on leave and performing on call duties for which I am responsible for emergencies dealing with public health issues.
